THE CLUB, THE OWNER, AND MANAGEMENT ASSUME NO LIABILITY FOR INJURIES CAUSED TO OR INCURRED BY ANY PARTICIPANT, MEMBER, FAMILY MEMBER, EXTENDED FAMILY MEMBER, GUEST OR OTHER PERSON OR FOR DAMAGE TO PROPERTY RESULTING FROM THE USE OF THE FACILITIES. CONSEQUENTLY, ANY PARTICIPANT, MEMBER, FAMILY MEMBER, EXTENDED FAMILY MEMBER, GUEST OR OTHER PERSON WHO USES OR ACCEPTS THE USE OF ANY OF THE FACILITIES, SERVICES OR TRANSPORTATION, OR ENGAGES IN ANY ATHLETIC CONTEST, EXERCISE OR OTHER CLUB ACTIVITY, EITHER ON OR OFF THE PREMISES, DOES SO AT HIS OR HER OWN RISK AND SHALL RELEASE, HOLD HARMLESS, AND WAIVE ANY CLAIMS AGAINST THE CLUB, THE OWNER, AND MANAGEMENT (THE "RELEASED PARTIES"), AND THEIR EMPLOYEES FROM ANY INJURY, DAMAGE, CLAIM, OR LIABILITY RESULTING FROM SUCH USE OR ENGAGEMENT. PARTICIPANTS ARE CHARGED WITH THE RESPONSIBILITY OF NOTIFYING THEIR FAMILY MEMBERS, EXTENDED FAMILY MEMBERS AND GUESTS REGARDING THIS RELEASE FROM LIABILITY AND DISCLAIMER. IN ADDITION, THE PARTICIPANT AGREES TO INDEMNIFY AND HOLD THE CLUB, THE OWNER AND MANAGEMENT FROM ANY CLAIM, DEMAND OR CAUSE OF ACTION ASSERTED AGAINST THE CLUB BY A FAMILY MEMBER, EXTENDED FAMILY MEMBER, OR GUEST OF THE PARTICIPANT. THIS RELEASE AND WAIVER SHALL NOT APPLY IN CASES WHERE THE CLUB, THE OWNER, AND/OR MANAGEMENT ACTED WITH INTENTIONAL NEGLIGENCE OR GROSS MISCONDUCT.
